2. TO CO-OPT NEW COUNCILLORS

It was resolved to co-opt Mr J Sweetman, Mrs A Sweetman and Mr P Iras. They each signed a Declaration of Acceptance of Office and joined the meeting. They were also given the Declaration of Interest forms to complete along with the Depensation Request Form and the GDPR Security Compliance Checklist.

- b. Dist Cllr Dickinson reported:
  - i. ELDC are looking at ‘children’s emotional wellbeing and mental health’. Two services are offered to young people for free at [www.kooth.com](http://www.kooth.com) and at [www.lpft.nhs.uk/young-people/lincolnshire/professionals/service-offer-and-referrals/healthyminds-lincolnshire](http://www.lpft.nhs.uk/young-people/lincolnshire/professionals/service-offer-and-referrals/healthyminds-lincolnshire)
  - ii. If anyone witness someone not picking up after their dog and is willing to sign a witness statement then a Fixed Penalty Notice can be issued. If the person with the dog does not know the dog has fouled then no Notice can be issued.
  - iii. The District Councillor Community Grant for Friskney Ward for the year 2019/20 has now all been allocated. I was happy to award £333 to Eastville, Midville and New Leake Village Hall to assist with necessary tree works. I awarded £71.14 along with 13 other councillors creating a total grant of £996 to Lindsey Blind Society for a Low Vision Assessment Kit which will be used within the district. I awarded £595.86 to Friskney Village Hall towards the upgrade of facilities at the Village Hall
