 - iii. ELDC are offering advice to businesses regarding safe working methods as we move out of Covid 19.

 - iii. Household waste recycling centres have had over 23,800 bookings.

 - vi. The barriers at Station Road have been moved back as far as they can be, the work should be finished by the end of June.

 - viii. Staff at LCC and at ELDC are currently working from home or have been re-deployed to help in other areas during the pandemic.
